2. GRANT OF RIGHTS

In consideration of being permitted to perform at MCS Comedy Explosion, and for other good and valuable consideration, I ("Performer") grant Michael Coleman Studios Network ("MCS"), MCSPronto.com, MCS Comedy TV, and their authorized affiliates, distributors, licensees and production partners the right to record my live performance and to photograph, reproduce, edit, package, promote, stream, broadcast, re-air and distribute the resulting recording.

3. STREAMING & TELEVISION USE

I authorize MCS to use my recorded performance on MCSPronto.com and MCS Comedy TV and through MCS affiliate television channels, streaming services, websites, apps, connected-TV platforms, digital media and authorized third-party distribution outlets. These rights include re-airing, clips, highlights, trailers, promotional material and compilations. These rights are worldwide and apply to media now known or later developed.

4. NAME, IMAGE & LIKENESS

I authorize MCS to use my legal name, professional/stage name, image, likeness, voice, photograph and performance excerpts in connection with the program and its advertising, publicity and promotion, without additional compensation other than the royalty described below.

5. EDITING

MCS may edit the recording for length, broadcast standards, technical delivery, captions, continuity, programming and promotional purposes. MCS will not intentionally edit the recording to falsely create a materially different statement or performance.

6. 10% COMEDIAN ROYALTY POOL

MCS will allocate ten percent (10%) of Net Streaming Revenue actually received by MCS from the applicable MCS Comedy TV program or special to a comedian royalty pool ("10% Royalty Pool"). The pool will be divided equally among qualifying comedians whose live performances are included in that program or special, unless a separate written agreement provides otherwise.

7. NET STREAMING REVENUE

"Net Streaming Revenue" means money actually received by MCS directly attributable to the applicable streaming exploitation, less reasonable third-party platform/distribution fees, payment-processing fees, refunds or chargebacks, taxes collected and remitted, and other direct third-party distribution costs. No royalty is owed on projected, invoiced but uncollected, or gross figures.

8. ROYALTY ACCOUNTING & PAYMENT

Royalty statements and payments will be provided at least quarterly after MCS receives applicable revenue. No payment is due for a period in which no Net Streaming Revenue has been received. If a Performer's royalty is less than \$25 for a statement period, MCS may carry the balance forward until it reaches \$25 or until final accounting. Performer must provide accurate payment and tax information, including a W-9 when requested.

9. NO GUARANTEE

Performer understands that MCS does not guarantee that the recording will be aired, streamed, re-aired, distributed or monetized, and does not guarantee a minimum number of viewers, subscribers, advertisers or royalty income.

10. PERFORMER REPRESENTATIONS

Performer represents that Performer has authority to sign this Release and that the performance and materials intentionally supplied by Performer do not knowingly violate the rights of another person or entity. Performer is responsible for obtaining permission for third-party material intentionally incorporated into the performance.

11. RECORDING OWNERSHIP

The audiovisual recording created by MCS, including MCS-created edits, graphics, packaging and promotional materials, will be owned or controlled by MCS, subject to Performer's royalty rights expressly stated in this Release. Performer retains ownership of pre-existing material except for rights necessary for MCS to use it as incorporated into the recorded performance.

12. RELEASE OF CLAIMS

To the extent permitted by law, Performer releases MCS and its owners, officers, employees, affiliates, licensees, distributors and production partners from claims arising solely from the authorized recording and exploitation described in this Release, except for claims involving royalties expressly due under this Release or rights that cannot legally be waived.

13. TERM, TERRITORY & GOVERNING LAW

The rights granted are worldwide and continue for the full period permitted by applicable law for exploitation of the recorded performance and related programming. This Release is governed by the laws of the State of California, unless a later written agreement states otherwise.

14. INDEPENDENT CONTRACTOR

Performer is appearing as an independent performer and is not an employee, partner, joint venturer or agent of MCS by signing this Release.

15. ENTIRE AGREEMENT / ELECTRONIC SIGNATURE

This Release contains the parties' understanding concerning the recording and exploitation of the performance. Any modification must be in writing and signed by the parties. Electronic, scanned or digitally delivered signatures may be treated as originals to the extent permitted by law.

SIGNATURES & ACKNOWLEDGMENT
